• Dr. Thomas Cleare provided an update of the PDIC meeting held on January 27, 2022.

- The PDIC reviewed the Index and Definitions document and discussed how to organize the document moving forward.
- The next PDIC meeting will follow-up on the Index and Definitions document and it will discuss the feedback gathered on the Health & Wellness domain.
- Stessy Cocerez provided an update on the Draft Element document and the timeline of the approval process.

REGULAR BUSINESS

<u>Agenda Item</u>: 3.C. Securing Our Future Initiative (SOFI) Update on Performance and Common Themes (James Green & Jodie Boisvert)

- James Green initiated the presentation on SOFI and provided context on the program as well as how SOFI fits into the Palm Beach County Opportunity Ecosystem.
- James Green also shared the goals of SOFI and its governance and structure.
- Jodie Boisvert reviewed historical and current SOFI data and spoke about program successes since the program's inception.
- James Green discussed the Self-Sufficiency Continuum and how SOFI works to move people towards self-sufficiency.
- Jodie Boisvert provided an overview of the agencies in the SOFI initiative. Ms. Boisvert also mentioned what their roles are and the types of services the participating families are receiving.
- Jodie Boisvert went over client demographics and presented a zip code overview of the SOFI participants.
- Jodie Boisvert reviewed the Community Conversation data results related to SOFI and discussed the findings.
- James Green concluded the presentation by sharing the status of various pieces of Policy Work that could affect the work of SOFI and/or impact the program participants.
- General discussion and questions occurred such as:
 - o If the reported numbers were cumulative and if they included the working youth
 - o Whether there has been discussion or availability of funding for summer youth jobs/internships
 - o Where the statistics surrounding the income needed for a single person to live originated from
 - o If there was a regularly developed and distributed report on SOFI

REGULAR BUSINESS

Agenda Item: 3.D. Notice of Funding Opportunity (NOFO) Presentation on Economic Stability & Self Sufficiency and subcategory of Intellectual & Developmental Disabilities (Natalie Diaz Rodriguez)

- Natalie Diaz Rodriguez provided the status of the FAA FY 2023 Economic Stability & Self-Sufficiency NOFO and shared the priorities that have been established.
- Natalie Diaz Rodriguez outlined the data sources, resources, and findings utilized for the Community Needs Assessment that has helped to inform the upcoming NOFO.
- Natalie Diaz Rodriguez discussed how the upcoming NOFO would play a part in addressing the development of community participants in the Self-Sufficiency Continuum.
- Natalie Diaz Rodriguez concluded the presentation by discussing the funding priorities and requirements for the NOFO.
- General discussion and questions occurred such as:
 - The inclusion of families who don't meet the NOFO's eligibility and how to access additional community resources
 - o The efforts around strategically planning for the future use of funding dollars
 - o Whether or not the NOFO will encourage the development of new childcare programs OR if agencies should be referring to pre-existing childcare resources
