### Agenda Item: 3.B. Birth to 22 Presentation (Randy Palo)

<u>Discussion</u>: Randy Palo presented on what Birth to 22 is, including its mission, goal and a brief history on how Birth to 22 started. He also shared a survey with the members that included findings on what the youth needs in order to succeed and thrive. He then provided some of the accomplishments of Birth to 22, its 2022 timeline, an
