NOW, THEREFORE, in consideration of the mutual covenants, promises, and agreements herein contained, the Parties agree as follows:

- 1. The above recitations are true and correct and incorporated herein.
- 2. The CONTRACT is hereby amended to extend the expiration date of the CONTRACT from June 19, 2024 to December 19, 2025.
- 3. The CONTRACT is hereby amended to increase the amount by \$1,150,000, from \$1,150,000 to \$2,300,000.
- 4. It is the intent of the Parties hereto that this AMENDMENT shall not become binding until the date executed by the COUNTY.
- 5. Except as hereby amended, changed or modified, all other provisions of the CONTRACT shall remain in full force and effect.
