Motion and Title: Staff recommends motion to receive and file: the official transcript for the closing of the Palm Beach County, Florida \$69,080,000 Airport System Revenue Bonds, Series 2006A and \$16,855,000 Airport System Taxable Revenue Refunding Bonds, Series 2006B for refunding the prior Bonds issued and improvements to Airport facilities (the "Bonds"), as authorized by Resolution R-2006-0727 on April 18, 2006.




