The County has encumbered \$304,125 (\$23,394/month) during the previous thirteen (13) months of the current fifteen (15) month term contract, which includes a three (3) month extension pursuant to the Director of Purchasing's authority. Purchasing is requesting a contract extension of six (6) months or a new contract whichever occurs first and an increase of \$158,792 over the previous authorized amount of \$332,481 which includes the Director of Purchasing's 10% funding authority while Purchasing re-solicits, evaluates and awards the re-bid. Increase is based on historical usage for the six (6) month extension. Awardee is located outside Palm Beach County in the City of Opa Locka, Florida. No SBE vendor submitted a bid on this project.
