### I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve the first amendment to the construction materials testing, geotechnical engineering & inspection annual contracts with:

- A) GFA International, Inc. (GFA), R2014-1127, whose original contract was dated August 19, 2014;
- B) Nutting Engineers of Florida, Inc. (Nutting), R2014-1128, whose original contract was dated August 19, 2014; and
- C) Tierra South Florida, Inc. (TSF), R2014-1126, whose original contract was dated August 19, 2014.

**SUMMARY:** Approval of these first amendments to the construction materials testing, geotechnical engineering & inspection annual contracts will extend the required professional services for one year, on a task order basis, from August 18, 2015 to August 18, 2016. The amendments with GFA, Nutting and TSF will also adjust the fee schedule as allowed in the original contract. THIS FIRST AMENDMENT to the Annual Construction Materials Testing, Geotechnical Engineering & Inspection Contract dated August 19, 2014, (R2014-1126), hereinafter "CONTRACT" by and between Tierra South Florida, Inc., hereinafter "CONSULTANT" and the Board of County Commissioners of Palm Beach County, a political subdivision of the state of Florida, hereinafter, "COUNTY".

### WITNESSETH

WHEREAS, on August 19, 2014, the CONSULTANT and COUNTY entered into a twelve month Annual Construction Materials Testing, Geotechnical Engineering & Inspection Contract for engineering services and other related tasks throughout Palm Beach County; and

WHEREAS, the CONTRACT provides that the contract may be extended, at the COUNTY's option for a defined period of time, not to exceed thirty-six months total contract time, upon approval of the Board of County Commissioners; and

WHEREAS, this is the first of the two allowable one (1) year term CONTRACT extensions per section 4.1; and

WHEREAS, by this amendment, the CONSULTANT and the COUNTY mutually agree to amend the CONTRACT terms to extend the expiration date of the CONTRACT from August 18, 2015 to August 18, 2016, with all original terms, conditions and unit prices adhered to.

WHEREAS, the original CONTRACT provides in section 5.3.2 that the rates may be adjusted by negotiation; and

WHEREAS, by this amendment, the CONSULTANT and the COUNTY mutually agree to amend the CONTRACT terms to modify the Fee Schedule of the CONTRACT from Exhibit B in the Original Contract to the revised Fee Schedule provided by Tierra South Florida, Inc. dated April 22, 2015, and attached hereto as Exhibit A.

NOW, THEREFORE, in consideration of the mutual covenants, promises, and agreements herein contained, the parties agree as follows:

- 1. The above recitations are true and correct and incorporated herein.
- 2. The CONTRACT, dated August 19, 2014, between the CONSULTANT and the COUNTY is hereby amended to extend the expiration date of the CONTRACT from August 18, 2015 to August 18, 2016.

- 3. The Fee Schedule shown as Exhibit B in the Original Contract is hereby modified as shown in the revised Fee Schedule provided by Tierra South Florida, Inc. dated April 22, 2015, and attached hereto as Exhibit A.
- 4. It is the intent of the parties hereto that this Amendment shall not become binding until the date executed by the COUNTY.
- 5. Except as provided herein, all other provisions of the Annual Construction Materials Testing, Geotechnical Engineering & Inspection Contract dated August 19, 2014, hereby confirmed shall remain in full force and effect.
