# I. EXECUTIVE BRIEF

**Motion and Title:** Staff recommends motion to approve: Work Authorization (WA) No. 4 to the 2019 Pipeline Continuing Construction Contract (Contract) with Johnson-Davis Incorporated (Contractor) for the CD03 Water Distribution System Improvements Phase 3: Berkshire (Project) in the amount of \$692,911.60.

**Summary:** On February 11, 2020, the Board of County Commissioners approved the Palm Beach County Water Utilities Department (PBCWUD) Contract (R2020-0160) with Contractor. WA No. 4 provides for the replacement of approximately 2,700 linear feet of asbestos cement water main varying in sizes; fire protection improvement and approximately 70 water services conversions located within the Berkshire residential community in West Palm Beach. This Contract was procured under the requirements of the Equal Business Opportunity Ordinance. On April 3, 2019, the Goal Setting Committee applied an Affirmative Procurement Initiative of a mandatory 20% Small Business Enterprise (SBE) subcontracting participation. The Contract provides for 20.07% SBE participation. WA No. 4 includes 19.71% SBE participation. The cumulative SBE participation including WA No. 4 is 22.22%. Contractor is a Palm Beach County Company. The Project is included in the PBCWUD FY20 Budget. (PBCWUD Project No. 15-102) <u>District 2</u> (MJ).

**Background and Justification:** The existing water mains to be replaced under the Project are substandard asbestos cement pipes and lack fire protection. The work provided by this Project will relocate the existing water mains and water services from the rear of the residential properties to the front within PBC right-of-way. Completion of the work provided for in WA No. 4 will restore the service life, increase hydraulic efficiency, improve the reliability and redundancy of the water distribution system and increase fire protection in the area. The Project will also help to reduce the operations and maintenance workload and associated cost.
