Motion and Title: Staff recommends motion to approve:

- A) Change Order No. 10 with J.W. Cheatham, LLC (JWC) in the amount of \$396,641.74 and a time extension of 104 days for Silver Beach Road, east of Congress Avenue to Old Dixie Highway (R2018-1330) (Project).
- **B)** A budget amendment of \$396,642 in the Road Impact Fee Fund Zone 1 to recognize reimbursement funding from the City of Riviera Beach Utility Special District (City) and appropriate it to the Project.

SUMMARY: Per PPM CW-F-050, this change order exceeds the threshold of \$100,000 and allowable time extensions relating to staff approvals of change orders to contracts as calculated by multiplying the number of days of the time extension request by the liquidated damages amount in the executed contract, and requires the Board of County Commissioners (BCC) approval. Change Order No. 10 will compensate JWC for costs and delays associated with removal, abandonment and relocation of existing City water main and sanitary sewer that were found to be in conflict with the construction of the proposed roadway; and will extend the contract time by 104 days resulting in a new completion day of April 20, 2021. The City agreed through Resolution 19-20UD to reimburse the full amount of Change Order 10 to Palm Beach County (County). The contract was approved on September 18, 2018, prior to the effective date of the Equal Business Opportunity Ordinance and pursuant to the Small Business Enterprise (SBE) Ordinance at the time. The SBE goal for all contracts is 15%. JWC committed to 15.5 % SBE participation. Their SBE participation for this change order is 1.4 %, and their cumulative SBE participation to date, including this change order, is 11.3 %. However, JWC expects to meet their SBE goal by completion of this contract. JWC is a Palm Beach County based company. District 7 (YBH)

Background and Justification: During construction of the Project, it was discovered that an existing City water main and sanitary sewer would be in conflict with construction of Avenue 'S' as well as the new frontage road along the south side of Silver Beach Road. The City was made aware and agreed to fully reimburse the County for the cost to relocate the water main and sanitary sewer. On November 20, 2018 the County and the City entered into an interlocal agreement (R2018-1733) for joint participation and project funding for construction of utility adjustments for the Project. The City passed Resolution 19-20UD on September 16, 2020 authorizing their Finance Department to issue payment for reimbursement of the additional costs of Change Order No. 10. An amendment to R2018-1733 will be brought to the BCC for approval once executed by the City.


