I. <u>EXECUTIVE BRIEF</u>

Motion and Title: Staff recommends motion to: (A) Accept on behalf of the Palm Beach County Sheriff's Office a FY2021 DNA Capacity Enhancement and Backlog Reduction (CEBR) Program Grant from the Department of Justice, Bureau of Justice Assistance in the amount of \$390,479 for the period October 1, 2021, through September 30, 2023; and (B) Approve a budget amendment of \$390,479 in the Sheriff's Grants Fund.

Summary: The Palm Beach County Sheriff's Office (PBSO) received an award for the DNA Capacity Enhancement and Backlog Reduction Program in the amount of \$390,479 for the period October 1, 2021 through September 30, 2023. The Forensic Biology Unit in the Crime Laboratory of PBSO services over 28 municipalities, the school systems and assists state and local federal agencies as needed. These funds will be used to continue to support the salary and benefits of two full time Forensic Scientists, training, travel, and contractual services that will increase the efficiency of the crime lab. There is no match requirement associated with this award. The Catalog of Federal Domestic Assistance (CFDA) number is 16.741 and the grant number is 15PBJA-21-GG-02985-DNAX. Countywide (LDC)

Background and Justification: The U.S. Department of Justice, Office of Justice Programs (OJP), Bureau of Justice Assistance FY 2021 Forensic DNA Capacity Enhancement and Backlog Reduction Program furthers the U.S. Department of Justice's mission by offering an opportunity for states and units of local government with existing crime laboratories that conduct DNA analysis to handle, screen, and analyze backlogged forensic DNA casework samples, as well as to improve DNA laboratory infrastructure and analysis capacity, so that forensic DNA samples can be processed efficiently and cost effectively. These improvements are critical to preventing future DNA backlogs and to helping the criminal justice system use the full potential of DNA technology.

The Forensic Biology Unit (FBU) of the Palm Beach County Sheriff's Office Crime

Laboratory is responsible for analyzing evidentiary material associated with criminal investigations for over 28 municipalities, the school system and local Federal agencies as needed. As the primary agency conducting DNA analysis for Palm Beach County, it is of the utmost importance that the FBU provide efficient and timely processing of all requested evidence. In 2015 the FBU underwent an NIJ grant funded Lean Six Sigma project which initially identified the average monthly demand for DNA analysis as 51 cases. Now, six years later, the demand for DNA analysis has risen significantly to an average of 93 case requests per month (~82% increase) without a proportional increase in agency funded staffing. In addition, on July 1, 2016 FLA. STAT. § 943.326 (2016) went into effect, requiring the submission of sexual assault kit evidence to the laboratory within 30 days of receipt and the completion of testing and analysis of evidence within 120 days of laboratory submission. To address the increases in case demand, the FBU is proposing to continue the grant funding of two full-time Forensic Scientists whose responsibilities include evidence preservation and screening in preparation for downstream DNA analysis. In addition, the FBU would use funds to support its Rapid DNA program through the purchase of consumables and software as well as enter into several contractual relationships which would directly relate to improving laboratory efficiency and maintaining capacity through relevant trainings and validation support. Funds would also be used to replace aging computers as well as support the continuing education of staff as required by the FBI Quality Assurance Standards. The overarching goal of this proposal is to increase the FBU's capacity to analyze forensic samples as well as to reduce sample turnaround times. The ability to increase a laboratory's capacity is heavily reliant on maintaining trained staff dedicated to casework. Solid staffing levels ensure that the FBU maintains lower turnaround times and controls backlog growth. The citizens of Palm Beach County have been and will continue to be provided with fully validated technologies and methodologies in forensic DNA analysis in order to provide the highest quality casework and prevent DNA backlog growth. As a result of funding from this grant, the PBSO FBU expects to continue its quest to increase efficiency and reduce turnaround time a la companya in terreta de la companya de la
