I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to receive and file: Amendment No. 1 to Contract for Provision of Services with Catholic Charities of the Diocese of Palm Beach, Inc., (Catholic Charities) (R2019-1722), to extend the end date from June 30, 2022 to June 30, 2024 and to increase funding by \$248,000 for a new total contract amount of \$620,000, for the provision of homeless prevention services.

Summary: The Division of Human Services received the 2019 Homeless Challenge and Temporary Assistance for Needy Families (TANF) Grant, which is also referred to as the Unified Homeless Grant Agreement (IP004). The grant provides emergency financial assistance to at-risk households facing the loss of their housing due to a financial crisis. The purpose of Amendment No. 1 is to extend the current contract for a two (2) year period, from July 1, 2022 through June 30, 2024, for an amount not to exceed \$248,000. The County originally subcontracted with Catholic Charities, for a total amount not-toexceed \$372,000. Catholic Charities will provide homeless prevention services through case management, financial assistance with rent/mortgage and utility payments. These services assist at-risk families from becoming homeless and remain stably housed. During FY 2019 - 2022, financial assistance was provided to 261 households and 951 individuals, which remain stably housed, by assisting with rent, mortgage and utility payments. The amendment will serve approximately 72 households annually with financial assistance to pay their rent/mortgage and/or utilities that is past due. An in-kind match of \$124,000 will be provided annually by Catholic Charities. This amendment was executed by the County Administrator in accordance with Agenda Item 3E-3, dated July 2, 2019, which delegated signature authority to the County Administrator, or designee. In accordance with County PPM No. CW-O-051, all delegated contracts, agreements, and grants must be submitted by the initiating department as a receive and file item. No County funds are required. (Division of Human Services) Countywide (HH)

Background and Justification: In January 2006, the Division of Human Services began serving as the Lead Entity for the Palm Beach County Homeless Continuum of Care (CoC). The CoC is the planning and evaluation body for the homeless service delivery system in Palm Beach County and is a requirement of the Housing and Urban Development Agency (HUD). The State Department of Children and Families Office on Homelessness works in conjunction with HUD to provide funding opportunities to assist persons who are homeless or are at risk of homelessness.

In accordance with BCC approval granting signature authority to the County Administrator, or designee, on July 2, 2019, your signature is needed on the First Amendment to Contract for Provision of Services with Catholic Charities of the Diocese of Palm Beach, Inc. (Catholic Charities) (2019-1722), for the period July 1, 2019 through June 30, 2024, for a total amount not-to-exceed \$620,000, for the provision of homeless prevention services,

The purpose of Amendment No. 1 is to extend the current contract for a two year (2) period, from July 1, 2022 through June 30, 2024, increase the total funding by \$248,000, reletter Section L of ARTICLE 13-Agency Programmatic Requirements, and incorporate Attachment L, Florida Department of Children and Families Contract IP004. Catholic Charities will provide homeless prevention services through case management, financial assistance with rent/mortgage and utility payments. These services will assist at-risk families from becoming homeless and remain stably housed. Catholic Charities will serve approximately 72 households annually during the contract period. An in-kind match of \$124,000 annually will be provided by Catholic Charities. No County match is required.

The Division of Human a Services serves as the Lead Entity for the Palm Beach County Homeless Continuum of Care (COC) pursuant to 420.624(6), F.S. The County serves as a pass thru for these grant funds. In accordance with PPM CW-O-051, Staff will submit this item to the BCC to allow the Clerk and Comptroller's Office to receive and file the item.

I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to receive and file: a Contract for Provision of Services with Catholic Charities of the Diocese of Palm Beach, Inc. (Catholic Charities), for the three (3) year period July 1, 2019, though June 30, 2022, in an amount not to exceed \$372,000, for the provision of homeless prevention services.

Summary: The Division of Human and Veteran Services received Unified Homeless Grant Agreement (IP004) to provide emergency financial assistance to at-risk families facing the loss of their housing due to a financial crisis. This is a three (3) year grant. The County subcontracted with Catholic Charities, for an amount not to exceed \$372,000. Catholic Charities will provide homeless prevention services through case management, financial assistance with rent/mortgage and utility payments. These services will assist at-risk families from becoming homeless and remain stably housed. During FY 2016-2018, financial assistance was provided to 307 households, which remain stably housed, by assisting with rent, mortgage and utility payments. Under the new contract, approximately 72 households annually will be served with financial assistance to pay their rent/mortgage and/or utilities that is past due. All funds must be expended no later than June 30th of each state fiscal year. An in-kind match of \$124,000 will be provided annually by Catholic Charities. On July 2, 2019, the Board of County Commissioners authorized the County Administrator, or designee, to execute contracts for this purpose. In accordance with County PPM CW-O-051, all delegated contracts, agreements, and grants must be submitted by the initiating Department as a receive and file agenda item. No County funds are required. (The Division of Human and Veteran Services) Countywide (HH)

Background and Justification: In January 2006, DHVS began serving as the Lead Entity for the Palm Beach County Homeless Continuum of Care (CoC). The CoC is the planning and evaluation body for the homeless service delivery system in Palm Beach County and is a requirement of the Housing and Urban Development Agency (HUD). The State Department of Children and Families Office on Homelessness works in conjunction with HUD to provide funding opportunities to assist persons who are homeless or are at risk of homelessness.

FIRST AMENDMENT TO CONTRACT FOR PROVISION OF SERVICES

In consideration of the mutual promises contained herein, the COUNTY and the AGENCY agree as follows:

WHEREAS, on November 5, 2019, the above named parties entered into a Contract, (R2019-1722), in an amount not to exceed \$372,000, to provide homeless prevention assistance to households at risk of becoming homeless, for the period from July 1, 2019 through June 30, 2022; and

WHEREAS, the original Contract has an expiration date of June 30, 2022 and is funded in the amount of THREE HUNDRED SEVENTY-TWO THOUSANDS DOLLARS (\$372,000); and

WHEREAS, the AGENCY must comply with the terms of the COUNTY'S Contract with the Florida Department of Children and Families, IP004 (R2019-1138), and that Contract must be made a part of the COUNTY'S agreement with the AGENCY; and

WHEREAS, the need exists to amend the Contract with the AGENCY, (R2019-1722), to update ARTICLE 2 - SCHEDULE and ARTICLE 3 - PAYMENTS, to replace Exhibit B, and to incorporate the entirety of the COUNTY'S Contract with the Florida Department of Children and Families, IP004 (R2019-1138) (New Attachment L).

NOW THEREFORE, the COUNTY and the AGENCY mutually agree that the Contract entered into on November 5, 2019, (R2019-1722), is hereby amended as follows:

- I. The foregoing recitals are true and correct and incorporated herein by reference.
- II. The first sentence of **ARTICLE 2 SCHEDULE** is amended to read:

The AGENCY shall commence services on July 1, 2019 and complete services on June 30, 2024.

III. The first paragraph of **ARTICLE 3 - PAYMENTS** is amended to read:

The COUNTY shall pay to the AGENCY for services rendered under this contract in an amount not to exceed SIX HUNDRED TWENTY THOUSANDS DOLLARS (\$620,000) over a five year period of which ONE HUNDRED TWENTY FOUR THOUSAND DOLLARS (\$124,000) IS BUDGETED IN GY2019, WITH AN ANTICIPATED ANNUAL ALLOCATION OF ONE HUNDRED TWENTY FOUR THOUSAND DOLLARS

(\$124,000) IN EACH SUBSEQUENT YEAR FOR THE TERM OF THE CONTRACT.

- IV. Section L of ARTICLE 13 AGENCY PROGRAMMATIC REQUIREMENTS is relettered to "J", and replaced in its entirely with the following:
 - J. Agency must comply with Attachments E2, F2, F2.1, F4, F4.1, G, H, I, J, K, and L. Failure to provide the information required in these attachments in a timely fashion and in the format required, and to comply with all of the terms of Attachment L, will constitute a material breach of this Contract and may result in termination of this Contract.
- V. Attachment B is replaced in its entirety with Attachment B-1, attached hereto and incorporated herein by reference.
- VI. Attachment L, Contract #IP004 (R2019-1138), between the COUNTY and the Florida Department of Children and Families, is attached hereto and incorporated herein by reference.
- VII. All other provisions of the Contract not modified in this First Amendment are still in effect and are to be performed at the same level as specified in the Contract.
