I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to:

- A) adopt a Resolution to approve Supplemental Agreement Number One (Supplemental) to the Local Agency Program (LAP) Agreement (R2021-1899), dated January 25, 2022 (Agreement) with the State of Florida Department of Transportation (FDOT) for the construction of Lyons Road/Sansbury's Way from Forest Hill Boulevard to Okeechobee Boulevard (Project);
- **B**) approve the Supplemental to the Agreement that increases the grant funding to \$5,099,624 and extends the expiration date of the Agreement from December 31, 2023 to June 30, 2024 for the Project; and
- C) approve a budget amendment of \$883,984 in the Transportation ImprovementFund to recognize the Supplemental funding from FDOT and appropriate it to the Project.

SUMMARY: Approval of this Supplemental and Budget Amendment will provide Palm Beach County (County) \$883,984 in additional grant funding for a total of \$5,099,624 for the Project and extends the expiration date of the Agreement from December 31, 2023 to June 30, 2024 . The Project will widen the roadway to add separated bike lanes on both sides of the roadway. The grant amount is being increased to reflect current costs and estimates of the Project. The local match is \$762,461 which is 13% of the estimated Project cost. The County will be responsible for all costs above the grant amount and for maintenance of improvements after construction is complete. The Catalog of Federal Domestic Assistance (CFDA) number for this grant is 20.205 Highway Planning and Construction. This Project is included in the Five-Year Road Program. Districts 2 & 6 (YBH)

Background and Justification: The LAP is intended to provide federal grants to local agencies. This Supplemental will provide the County additional grant funding for the construction of the Project and extend the expiration date of the Agreement.



Installation of a 5ft wide bike lane with a 2ft raised concrete separator on both sides of the road throughout the limits of this project along with milling and resurfacing and widening of the road. Two overhead school zone flashers will be installed to replace the existing post-mounted flashers on Lyons Road at Pioneer Road and Lyons Road at 7th Place S./Wellington View Drive.

Reason for Supplement and supporting engineering and/or cost analysis:

Termini SR-882/Forest Hill Bv to SR-704/Qkeechobee Bv

This supplemental agreement reconciles the LAP Agreement total project cost with the Department's concurrence and Local Agency construction bid award for FM#444370-1-58-01. This decreases the total funds by \$99,589.00. The revised Federal Funds amount is \$5,099,624.00 and the revised Local Funds amount is \$762,461.00. Refer to Exhibit "B" attached hereto and made a part hereof which replaces Exhibit "B" that is attached to the original Agreement.

This supplemental agreement also extends the LAP Agreement to June 30th, 2024 due to the revised construction completion date of January 2024. The construction completion date was revised due to a delay in materials availability.

This supplemental agreement amends the original agreement paragraph 3.0 Term of Agreement as follows: The Recipient agrees to complete the project on or before June 30th, 2024.
