**I. EXECUTIVE BRIEF**

**Motion and Title:** Staff recommends motion to receive and file: twenty-seven (27) fully executed lighting agreements with Florida Power & Light Company (FP&L) for various locations within Palm Beach County.

**SUMMARY:** In accordance with Countywide PPM CW-O-051, all delegated contracts, agreements, and grants must be submitted by the initiating Department as a receive and file agenda item. These agreements were executed by the County Engineer, per Resolution R2020-0990. The table of executed agreements details specific details and locations. Countywide (YBH)

**Background and Justification:** FP&L agreements are based on what type of street lighting fixture and/or pole is being installed and/or removed. "Street Lighting" agreements are utilized for installation and/or removal of High Pressure Sodium street lights and poles. "Premium Lighting" agreements are utilized for the installation and/or removal of Light-emitting Diode (LED) street lights and poles submitted to FPL prior to December 31, 2021. "LED Lighting" or "Lighting (new name in effect as of January 1, 2022)" agreements are utilized for the installation and/or removal of LED street lights and poles submitted to FPL after December 31, 2021. Resolution R2020-0990 delegates authority to the County Administrator or designee to enter into street light agreements on behalf of the Board of County Commissioners. The County Administrator designated authority to the County Engineer on September 24, 2020.
