I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: a Contract for the Lucerne Lakes Valves and Valve Replacement (Project) with Foster Marine Contractors, Inc. (Contractor) in the amount of \$1,496,834.

Summary: On April 5, 2023, the Palm Beach County Water Utilities Department (PBCWUD) received one (1) bid for the Project. Contractor was determined to be the lowest responsive and responsible bidder in the amount of \$1,496,834. The Project provides for all materials, labor, supervision, equipment, supplies, fees, expertise, and services necessary for the installation of 16 large diameter valves within Lucerne Lakes' residential community and throughout PBCWUD's service area. The construction services generally consist of the installation of valves on water mains, force mains, and all associated appurtenances.

This Project was procured under the requirements of the Equal Business Opportunity Ordinance. On February 1, 2023, the Goal Setting Committee applied an Affirmative Procurement Initiative (API) of a minimum mandatory 12% Small Business Enterprise (SBE) subcontracting participation. Contractor has met the established API. The Contract provides for 29.44% SBE participation. Contractor is a Palm Beach County based company. The Project is included in the PBCWUD FY23 budget. (PBCWUD Project No. 21-011) <u>Countywide</u> (MWJ)

Background and Justification: The work to be completed under this Project is part of the continued improvement, restoration and repair of the water and force main infrastructure in the PBCWUD service area. The completion of this Project will allow for isolation of pipelines during pipe breaks, thereby reducing emergency repair costs and minimizing the interruption of water and sewer service to customers.
