I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Consultant Service Authorization No. 7 (CSA) to the Civil Engineering Annual Services Contract (R2022-0464) dated May 17, 2022 (Contract) with Mock, Roos & Associates, Inc. (MRA) in the amount of \$254,972.96 for the Lantana Road Drainage System Study (Project).

SUMMARY: Approval of this CSA will allow MRA to prepare a report of findings and recommendations for addressing deficiencies in two sections of the existing drainage system on Lantana Road between Military Trail and Congress Avenue. On June 16, 2021, the Goal Setting Committee applied Affirmative Procurement Initiatives of a 20% minimum mandatory Small Business Enterprise (SBE) participation and a Minority Business Enterprise preference for African American owned firms. MRA agreed to 27% SBE participation for the Contract. There is no SBE participation for this CSA. MRA has an office located in Palm Beach County (County). This **Project is included in the Five-Year Road Program.** District 2 (YBH)

Background and Justification: On May 17, 2022, the Board of County Commissioners (BCC) approved the Contract with MRA to provide the professional services for civil design throughout the County. The fee, as detailed in **Exhibit B** of the attached CSA, has been negotiated as just and reasonable compensation as follows:

OVERVIEW

Palm Beach County maintains a drainage system mostly comprised of swales, inlets, culverts, and outfall pipes serving the entire length of Lantana Road. Lantana Road is a 6-lane paved roadway with curb, gutter and sidewalks on both sides of the street. It has an underground piped drainage system consisting of curb inlets, storm water collection boxes, manholes and piped outfalls. Palm Beach County Road and Bridge Division (PBC R&B) indicates that they have observed roadway flooding, roadway surface depressions, potential sinkholes, and believe that certain portions of the existing system may be functioning below its intended capacity. PBC R&B have identified what they consider the two worst segments of the roadway for frequent flooding.

The County has requested that Mock•Roos provide engineering services to investigate the conditions of the existing drainage system at these two segments of Lantana Road and provide potential solutions to alleviate the flooding. The two roadway segments are:

- 1. From Military Trail to Willowood Lane, encompassing approximately 1,400 lineal feet of roadway right-of-way.
- 2. From Island Club Drive to about 200 feet east of Seminole Drive, encompassing approximately 1,700 lineal feet of Lantana Road right-of-way.

SCOPE OF SERVICES DESCRIPTION

- 1. Research County records to obtain as-built construction plans and related data of the two segments of the Lantana Road drainage system.
- 2. Perform a review of the applicable construction documents to identify existing outfalls, main trunk lines, cross drains, side drains, manholes and surface collection inlets.
- 3. Prepare a master drainage exhibit for use in performing, and documenting study findings.

- 4. Perform a formal site visit to confirm the presence of collection structures with County staff and discuss reported drainage issues and concerns. Review above ground conditions and photo document findings.
- 5. Provide and coordinate the services of a subconsultant, Shenandoah General Construction, LLC, to obtain additional underground piping and structure investigations using CCTV to complement information provided by the County, and determine, as best as possible, underground pipe and structure conditions for each of these roadway drainage systems. It is initially estimated that as much as 4,500 lineal feet of storm drainage piping will require inspections. This value could change during the course of the investigations. These investigations will be obtained from Shenandoah General Construction, LLC, an experienced infrastructure inspection company with CCTV capabilities under a *reimbursable allowance*. If it is determined that additional allowance is required, a supplement will be submitted for approval. This allowance is based on the following:
 - a. We presume that the total 3,100 LF project has up to 4,500 LF of underground pipelines, including side drains, cross drains and outfall pipes. We also presume that about 70% of these pipelines could be as large as 42" diameter or greater. We estimate that approximately 22 access structures are available to obtain the necessary information.
 - b. Maintenance of Traffic around the pipe inspection equipment will be required.
 - c. Night-time work may be required.
 - d. The initial allowance will include these elements and other work that becomes necessary to determine conditions of the applicable underground storm drainage system of Lantana Road. Should the initial allowance be inadequate to complete the project, additional reimbursable funds will be required.
- 6. Perform a review of the CCTV results of the existing underground drainage systems. This review is intended to identify deficiencies in pipes or drainage structures that may be affecting their proper performance. Deficiencies will be catalogued by location and probable impact upon the existing drainage system.
- 7. Perform up to two site visits during localized rainfall events to observe existing drainage system functionality and confirm findings of any underground deficiencies. Photo documentation exhibits will be obtained as necessary.
- Coordinate with Palm Beach County staff to identify potential solutions at each selected area of deficiency, to repair, clean or otherwise restore the system to its original intended function. Evaluation of potential solutions will include pipe/structure replacement and/or various rehabilitation methods. No evaluation of system capacity or ICPR modeling is included.
- 9. Develop a general proposed improvements exhibit at each problem location.
- 10. Provide a conceptual level Engineer's Opinion of Probable Construction Cost for each potential solution.
- 11. Prepare and submit a draft Letter Report documenting the evaluation, potential solutions and conceptual costs outlined above.
- 12. Meet with County staff, incorporate comments, and prepare a final Letter Report for the County's use (to be submitted electronically).

ANTICIPATED DELIVERABLES

The following items of work shall be the project deliverables:

A Letter Report documenting the drainage evaluation activities, including conceptual diagrams, conceptual construction cost estimates, and recommendations for improvements where possible. Two (2) hard copies with electronic versions of the completed report will be provided in .pdf format.

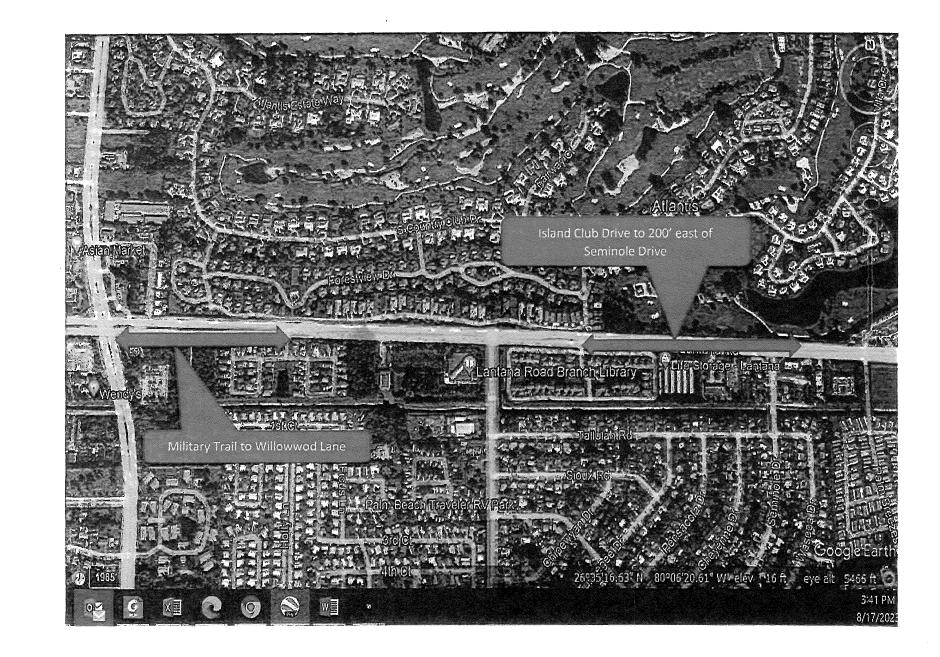
