I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: 1 precinct boundary change and 1 precinct creation, submitted by Wendy Sartory Link, Supervisor of Elections, as required by Section 101.001(1), Florida Statutes.

Summary: 1 precinct boundary change and 1 precinct creation are recommended by Wendy Sartory Link, Supervisor of Elections (SOE), due to a Community Development District becoming elected by popular vote. District 1 (AH)

Background and Justification: Section 101.001(1), Florida Statutes, requires that precinct boundary changes must be approved by a majority of the Board of County Commissioners, upon recommendation and approval of the SOE. Due to a Community Development District becoming elected by popular vote, the SOE is recommending a change to the size of 1 precinct and the addition of 1 precinct. 
