I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to receive and file: eight (8) Grant Adjustment Modifications (GAM) with the US Department of Justice (DOJ), Office on Violence Against Women (OVW), Grants to Improve Criminal Justice Response Program (ICJR) (CFDA#16.590)(15JOVW-21-GG-02012-ICJR), which facilitated administrative filing and approvals through April 30, 2024 as follows:

- 1) #552187: Budget Clearance;
- 2) #556215: Approve Personnel Change;
- 3) #572073: Approval to attend a Non-ICJR Training;
- 4) #569536: Approval to attend a Non-ICJR Training;
- 5) #572702: Approval to update staff attending Non-ICJR Training;
- 6) #574291: Approve Personnel Change;
- 7) #587655: Approve Personnel Change, and
- 8) #581052: Approve Budget Modification.

Summary: As per grant guidelines, certain expenditures and work products require approval from the OVW ICJR grant manager. The approval process is facilitated by drafting a GAM and submitting it through the OVW's JustGrants Grant Management web portal. GAM #552187 approved the grant award Budget. GAM #556215 approved the hiring of Jacqueline Jackson as Grant Coordinator and Nicole Martinez-Collazo as the Victim Advocate. GAM #572073 approved four Forensic Nurses to complete the Virtual Intimate Partner Violence Nurse Examiner Training offered through the International Association of Forensic Nurses (IAFN) organization. The GAM also approved payment of IAFN annual membership fee for one Forensic Nurse. GAM #569536 approved two Victim Services staff and one grant Partner Staff from Aid to Victims of Domestic Violence to travel to the End Violence Against Women International (EVAWI) Conference on Sexual Assault, Domestic Violence, and Fighting for Change April 11-13 2023. GAM #572702 updated the names of staff attending the EVAWI conference. GAM #574291 approved Kira Laffe to replace Jacqueline Jackson as Grant Coordinator. GAM #587655 approved Winter Jones to replace Kira Laffe as Grant Coordinator, GAM #581052 approved a budget modification to adjust grant staff salaries based on Palm Beach County budget approvals, allow project partner Aid to Victims of Domestic Abuse, Inc. to purchase two laptops for grant staff, host a website, allocate additional money to community partners, replaced Men Stopping Violence, Inc. with Lee Giordano to implement Tactics and Choices programs to hold offenders accountable and decreased the advertising budget. R2014-1633 authorized the County Administrator or designee to execute future awards, contracts, sub-recipient agreements and sub contracts and amendments/modifications utilizing funding from the DOJ, OVW on behalf of the Board of County Commissioners. Department Director

Background and Justification: The DOJ, OVW awarded Palm Beach County funding in the amount of \$1,000,000 through the Improving Criminal Justice Responses Program for the project period October 1, 2021 through September 30, 2024. The focus of the grant is to enhance victim safety and hold offenders accountable through a coordinated community response team (CCR) to respond to incidents of domestic violence, dating violence and stalking. In order to meet this need, the County's Public Safety Department Victim Services Division collaborated with Aid to Victims of Domestic Abuse, Inc., to coordinate the CCR activities and provide victim advocacy, PBC Criminal Justice Commission, and Battered Women's Justice Project, Inc. to provide a project evaluation. The CCR will start with the development of a multidisciplinary team to identify and address the need for consistent response protocols, comprehensive services and referrals for victims of Intimate Partner Violence (IPV) and accountability for offenders. Once implemented, it will evolve into a coherent process wherein responders and service providers take collective responsibility for a victim's experience during every stage of the process instead of just during one piece. This is the fourth time the County has been awarded this three-year grant and victims of domestic violence, dating violence, sexual assault and stalking and the array of responders and service providers who work with them in the County will be impacted by the implementation of this worthwhile project.

Goal 2: Enhance responses, through specialized training and policy/protocol development for prosecutors and prosecution-related personnel regarding best practices to ensure offender accountability, victim safety, and victim consultation. Obj. 2: Increase victim satisfaction with the prosecution; Obj. 3: Increase offender accountability; Obj. 4: Increase victim safety. The IAFN training will support forensic nurses in enhancing evidence collection in Intimate Partner Violence Cases. Palm Beach County Victim Services will increase the capacity of our forensic nursing team to begin utilizing forensics in IPV cases in hopes of increasing prosecution and support for victims. The training includes interactive online modules, handouts, articles, and video simulations with patients who have experienced intimate partner violence and strangulation, including an exam of a pregnant patient. Goal 3: Strengthen victim services. Obj:1 OVW Purpose area: #5 (to strengthen victim services for victims of IPV). The medical forensic exam and dynamics of intimate partner violence training offered will strengthen the services available to victims.

Justification: Salary changes for Palm Beach County Grant Personnel. Goal 3: Strengthen victim services. Victim Advocate provides direct services to victims of intimate partner violence; Grant Coordinator oversees the project and ensures that all project partners are on track. When the budget was first approved, salaries were based on 3% increases over the three years. Palm Beach County approved salary increases of 6%. Additionally insurance costs for staff are higher than anticipated along with other fringe including Florida Retirement System employer contributions.

Justification: Change in provider for the "Tactics and Choices" class. Additional funding for providers who will teach the class. Goal: Offender Accountability. The original organization, Men Stopping Violence no longer offered the training needed for community partners to teach the "Tactics and Choices" curriculum. Lee Giordano, who developed the class and curriculum, left the Men Stopping Violence Organization and is now a sub-contractor who continues to offer the training for others to teach the class and bring the curriculum to other communities. Additional funding is needed for community partners who will take the training to learn the curriculum and teach the class. The community partners will take referrals from agency partners to teach the class. The original funding based on the resources needed by community partners was not sufficient.

Justification: Purchasing two laptops, 2 monitors/cables, and creating a website for the Domestic Violence Coordinated Community Response Team will assist us in meeting the specific goals and objectives below. Goal 1: Develop a CCR Obj. 1 Increase access to services for victims of domestic violence; promote internal information sharing/role clarification/training for CCR members Obj. 6 increase community awareness about available resources

Goal 3: Strengthen victim services. Obj. 4: increase access to services for victims with limited English proficiency

The laptops will be essential tools to support the team's work. The Victim Advocate will be able to work remotely and travel to meet with clients who are unable to come to the office. This will enable us to provide in-person supportive counseling, injunction for protection assistance, safety planning and other services to victims even when they cannot come to us. This is especially important for those who live in rural areas with limited transportation options, making it difficult for them to access the services they need. The victim advocate will use the laptop to collect and maintain information about victims, create safety plans, and access online resources. The domestic violence coordinated community response project coordinator will use the laptop to manage and organize the team's activities, draft reports and correspondence, and access online resources.

The Domestic Violence Coordinated Community Response Team aims to provide a comprehensive and coordinated response to domestic violence cases. As part of this effort, the team has identified a need for a website/domain to improve communication and information sharing among team members and between the team and external stakeholders. The website will serve as a central hub for team activities, including training and education, community outreach, and best practices. The website will host a range of training and educational resources for team members and external stakeholders, such as law enforcement officers, attorneys, and victim advocates. This will help ensure that all stakeholders have the knowledge and skills necessary to respond effectively to domestic violence cases.

The website will serve as a platform for the team to engage with the community, share information about domestic violence, and promote awareness. The website will be designed and maintained by our grant partner AVDA with expertise in website development and design. AVDA will work closely with Palm Beach County Victim Services and the Domestic Violence Coordinated Community Response Team to ensure that the website meets the team's needs and objectives.

We believe that these two investments – the laptops, monitors/cables and website/domain – will greatly improve our ability to serve victims and connect them to the resources they need.

Budget:

We will modify the out-of-pocket expenses and instead of furniture (\$3,000) and one computer (\$2,000) the \$3,000 will be reallocated towards the second computer and website. The monthly mileage expense will be reduced to cover the website/domain and laptop expenses.

The local mileage will be reduced to 3,279 miles per year * 2 years @\$.445/per mile*2=\$5,836. Community Services providers indicated need for additional funding to support staff attending the training in order to deliver the class. Based on number of offender referrals to community service providers, 200 is a practical number. \$13,750 has been reallocated from Supplies and \$1,250 from the offender referral classes to provide this funding to the Community Service providers. Phone Interpreter Services \$2,006.78, has been removed, as this service was not being utilized and the funding was needed for salaries. Advertising has been reduced by \$36,647.00 due to not taking place during year one. These amounts have been reallocated to fund the increase in personnel and fringe benefits due to annual 6% increase in salaries and promotions to employees with higher pay rates.

The two positions and the forensic nurse examiner pay directly support the project activities. Each position is employed by Palm Beach County Victim Services (PBCVS). The salary rate computation includes an anticipated 3% pay increase in years 2 and 3 of the project period. The salaries for the positions were approved by Palm Beach County Human Resources. 1) Project Coordinator - Due to the grant starting late, the first year's actual salaries were reduced by 1,000 hours. Staff change in year 3 with new staff member being in position for 240 hours and then received an internal promotion with another grant. New ICJR staff in year 3 also received an internal promotion and

has higher rate of starting pay. 2) Victim Advocate – Due to the grant starting late, the first year's actual salaries were reduced by 989 hours. Actual increase was 6% for years 2 and 3. Changes in salaries due to turnover in staff and pay rate changes due to promotions.

The Victim Services Project Coordinator: The Project Coordinator will oversee the system aspects of the project and will manage the grant and ensure all project partners are on track, as well as promote the CCR and other prevention activities in PBC.

The Victim Services Advocate: The victim advocate will provide direct services, including on-call crisis field response, advocacy, and accompaniment, to victims of domestic violence, sexual assault, dating violence and stalking in Palm Beach County. The advocate will also assist with training responders and community providers on the enhanced CCR.

The Forensic Nurse Examiners will provide timely, thorough, victim-centered, medically focused assessment and forensic evidence collection of IPV cases referred and assigned through Palm Beach County Victim Services and Certified Rape Crisis Center (PBCVS). The forensic nurse examiner will perform patient assessment, risk evaluation, collection and documentation of forensic evidence, discharge planning and referrals for additional support and care. Forensic examiners are paid a flat fee per case. There is a \$300 reduction due to the increasing dollar amount per exam and the decreasing number of exams to be conducted.

Aid to Victims of Domestic Abuse (AVDA) will be a subawardee that provides a full-time Domestic Violence Certified Advocate and access to shelter (based on availability) for the duration of the project. AVDA will provide project support, participate in monthly CCR and sub-committee meetings, and will assist with providing training to community-based direct service providers and CCR members. Costs are based on AVDA's current salary and benefit rates. The Victim Advocate will dedicate 100% of their time by providing direct services to domestic abuse sexual assault victims. They will offer crisis intervention, safety planning, supportive counseling, advocacy, and referrals. They will also be responsible for community training. They will report to the Outreach Services Manager. Reduction in mileage is based on previous amounts actually expended.

The IPV CCR Coordinator will dedicate 100% of their time and will be responsible for organizing and managing the full scope of activities necessary to oversee the coordinated community response (CCR) in Palm Beach County in addition to ensuring compliance with program requirements and serving as the central contact for all project activities. They will report to the Program Services Director

The Outreach Services Manager will be funded 5% by OVW. The Outreach Services Manager is responsible for contributing in the management of outreach, prevention, and community education programs. They provide direct supervision to the Victim Advocate.

The **Program Services Director** will be funded 5% by OVW. The Program Services Director is responsible for contributing in the management of residential and outreach programs. They provide direct supervision of the Outreach Services Manager and the IPV CCR Coordinator. The allocation includes a 4.5 cost of living increase for each year.

Local Program Mileage is anticipated for the Victim Services Advocate and CCR Coordinator for use of their privately owned vehicle when traveling between the Shelter location, main office, and all partner organizations. Paychex Business Solutions process payroll/benefits for the listed positions. The purchase of one computer, monitor, speakers, desk and chair supports the work of AVDA project staff.

Contract with BWJP A logic model, developed by the CCR members in conjunction with BWJP, will measure progress toward achieving this proposal's goals and vision. It will be a roadmap to make sure the project is on track. The logic model will provide a clear identification of goals (outcomes), inputs and activities. The BWJP will work with the CCR to assess the work for continuous improvement of the process. The amount allocated is 3% of the total project budget, which is what is allowed per the solicitation.

Contract with Men Stopping Violence Lee Giordano (Consultant) will provide Two MSV trainers for a Two-Day Tactics and Choices training to PBC staff and facilitators on important domestic violence intervention dynamics and on the content and facilitation skills necessary to teach Tactics and Choices. Lee Giordano will facilitate one Tactics and Choices class for trainees to observe content and facilitation. Trainees would then process the experience with the Giordano training team. PBC staff and facilitators will receive ongoing feedback and support from The Girodano training team as they begin teaching Tactics and Choices. Lee Giordano will provide a Two-Day IPV PEC training to PBC staff (grant coordinator as an observer) and contracted facilitator (chosen through a solicitation of community providers) on important domestic violence intervention dynamics and on the content and facilitation skills necessary to teach IPV PEC. Consultant will facilitate one IPV PEC class for contracted provider to observe content and facilitation. Contracted provider would then process the experience with the Consultant's training team. Contracted provider will receive ongoing feedback and support from the Consultant's training team as they begin teaching IPV PEC.

Contracts with Community Service Providers (Tactics and Choice Classes): in order to hold offenders accountable, PBC will implement "Tactics and Choices" a class that examines men's use of abusive and intimidating tactics against women. This curriculum is a best practice developed by Lee Giordano formerly of Men Stopping Violence, a 37- year old organization the focuses on ending gender-based violence by educating and organizing men to be part of the solution. PBC will make the course available to offenders in civil domestic violence cases, child abuse cases and cases that are not prosecuted by the State Attorney. PBCVS will solicit providers from PBC per the OVW procurement process.

(IPV PEC Classes): in order to hold offenders accountable, PBC will implement "IPV PEC" a class that examines men's use of abusive and intimidating tactics against

women. This curriculum is a best practice developed by Lee Giordano. PBC will make the course available to offenders in civil domestic violence cases, child abuse cases and cases that are not prosecuted by the State Attorney, PBCVS will solicit providers from PBC per the OVW procurement process. Community Services providers indicated need for additional funding to support staff attending the training in order to deliver the class. Based on number of offender referrals to community service providers, 200 is a practical number. (The classes are for adult offenders involved in civil cases. No children will be served.)
