I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: a First Amendment to Contract for Medical Director Services with Elite Medical Specialists, LLC (R2021-1843) (Contract) to extend the term for one (1) 12-month period beginning January 1, 2025 through December 31, 2025 and to increase the amount of the contract to \$255,000 for the renewal period, with a not to exceed total contract amount of \$992,400.

Summary: The Contract, which provides the terms and conditions under which Elite Medical Specialists, LLC provides medical director services to Palm Beach County Fire Rescue (PBCFR) is set to expire on December 31, 2024. The original contract was approved by the Board of County Commissioners (BCC) on December 7, 2021, R#2021-1843; for a term of three (3) years with two (2) 12-month renewal options. The parties desire for PBCFR to continue receiving the services provided by Elite Medical Specialists LLC, which include the requirements for additional physicians to serve as Associate Medical Directors in order to provide increased training classes to the Paramedics and EMT's, an increased level of time spent in the field for supervision/observation of skill levels, and availability of 24-hour emergency consultation. This First Amendment extends the term, increases the Contract amount and updates standard County provisions. Countywide (SB)

Background and Justification: State law requires PBCFR, as an Emergency Medical Services Provider, to contract for medical director services with a Florida licensed Doctor of Medicine or Doctor of Osteopathic Medicine who meets all criteria of Chapter 401, Florida Statutes, and the Rules of the Department of Health, Chapter 64J-1, F.A.C. On December 7, 2021, the Contract was approved for a period of three (3) years with two (2) 12-month renewals at the sole discretion of the County. After approval of this First Amendment, there is one (1) remaining renewal option.

FIRST AMENDMENT TO CONTRACT FOR MEDICAL DIRECTOR SERVICES (Contract No. FR2021-01)

THIS FIRST AMENDMENT, dated December 5, 2024, to Contract No. FR2021-01, dated December 7, 2021, is made by and between Palm Beach County, a political subdivision of the State of Florida, by and through its Board of Commissioners, hereinafter referred to as the "COUNTY", and Elite Medical Specialists, LLC, P.O. Box 2764, Jupiter, Florida 33468, a limited liability corporation authorized to do business in the State of Florida, hereinafter referred to as the "MEDICAL DIRECTOR" or "CONTRACTOR".

WITNESSETH:

WHEREAS, the parties have entered into that certain Contract dated December 7, 2021, hereinafter referred to as the "Contract", whereby the CONTRACTOR is to provide Medical Director Services to the Fire Rescue Department in accordance with Exhibit A, Scope of Work/Services, and Appendix A, CONTRACTOR's proposal dated October 26, 2021, and Exhibit B, Business Associate Agreement; and

WHEREAS, the Contract provided for a three year term expiring December 31, 2024, with two twelve-month renewals at the COUNTY's discretion;

WHEREAS, the parties desire to exercise the first option for renewal of the Contract for the period of January 1, 2025, through December 31, 2025 (First Renewal Period).

NOW THEREFORE, in consideration of the mutual covenants and agreements expressed herein, the COUNTY and the CONTRACTOR agree as follows:

 ARTICLE 1 – SERVICES, the second paragraph is hereby amended to read as follows:

The COUNTY's representative/liaison during the performance of this Contract shall be <u>Patrick J. Kennedy</u>, <u>Fire Rescue Administrator</u>, telephone (561) 616-7000.

2. ARTICLE 3 - SCHEDULE is hereby amended to read as follows:

The CONTRACTOR shall commence services on January 1, 2022, and complete all services by December 31, 2025, with one (1) remaining Twelve (12) month renewal at the sole discretion of the COUNTY.

Reports and other items shall be delivered and/or completed in accordance with Exhibit A.

3. <u>ARTICLE 4 – PAYMENTS TO THE MEDICAL DIRECTOR</u>, the first paragraph of Subsection A is hereby amended to read as follows:

The total amount to be paid by the COUNTY under this Contract for all services and materials shall not exceed an amount of two hundred, fifty-five thousand dollars and no cents (\$255,000) for the First Renewal Period, with a not to exceed total contract amount of nine hundred, ninety-two thousand four hundred dollars and no cents (\$992,400).

4. <u>ARTICLE 26 – SCRUTINIZED COMPANIES</u> is hereby amended to read as follows:

A. As provided in section 287.135, Florida Statutes, as may be amended, by entering into this Contract or performing any work in furtherance hereof, the CONTRACTOR certifies that it, its affiliates, suppliers, subcontractors and consultants who will perform hereunder, have not been placed on the Scrutinized Companies that Boycott Israel List, or is engaged in a boycott of Israel, pursuant to section 215.4725, Florida Statutes, as may be amended. Pursuant to section 287.135(3)(b), Florida Statutes, as may be amended, if CONTRACTOR is found to have been placed on the Scrutinized Companies that Boycott Israel List or is engaged in a boycott of Israel, this Contract may be terminated at the option of the COUNTY.

B. When contract value is greater than \$1 million: As provided in section 287.135, Florida Statutes, as may be amended, by entering into this Contract or performing any work in furtherance hereof, the CONTRACTOR certifies that it,

its affiliates, suppliers, subcontractors and consultants who will perform hereunder, have not been placed on the Scrutinized Companies With Activities in Sudan List or Scrutinized Companies With Activities in Iran Terrorism Sector List created pursuant to section 215.473, Florida Statutes, as may be amended, or is engaged in business operations in Cuba or Syria. Pursuant to section 287.135(3)(a), Florida Statutes, as may be amended, if CONTRACTOR is found to have been placed on the Scrutinized Companies With Activities in Sudan List, or been engaged in business operations in Cuba or Syria, or has been placed on a list created pursuant to section 215.473, Florida Statutes, relating to scrutinized active business operations in Iran, this Contract may be terminated at the option of the COUNTY.

If the COUNTY determines, using credible information available to the public, that a false certification has been submitted by CONTRACTOR, this Contract may be terminated and a civil penalty equal to the greater of \$2 million or twice the amount of this Contract shall be imposed, pursuant to section 287.135, Florida Statutes, as may be amended. Said certification must also be submitted at the time of Contract renewal, if applicable.

5. <u>ARTICLE 28 – NOTICE</u> is hereby amended to read as follows:

All notices required in this Contract shall be sent by certified mail (return receipt requested), hand delivered or sent by other delivery service requiring signed acceptance.

6. ARTICLE 33 - COUNTERPARTS is hereby added to read as follows:

This Contract, including any exhibits referenced herein, may be executed in one or more counterparts, all of which shall constitute collectively but one and the same Contract. The County may execute the Contract through electronic or manual means. CONTRACTOR shall execute by manual means only, unless the County provides otherwise.

7. <u>ARTICLE 34 – DISCLOSURE OF FOREIGN GIFTS AND CONTRACTS WITH FOREIGN COUNTRIES OF CONCERN</u> is hereby added to read as follows:

Pursuant to section 286.101, Florida Statutes, as may be amended, by entering into this Contract or performing any work in furtherance thereof, the CONTRACTOR certifies that it has disclosed any current or prior interest of, any contract with, or any grant or gift received from a foreign country of concern where such interest, contract, or grant or gift has a value of \$50,000 or more and such interest existed at any time or such contract or grant or gift was received or in force at any time during the previous five (5) years.

8. <u>ARTICLE 35 – HUMAN TRAFFICKING AFFIDAVIT</u> is hereby added to read as follows:

CONTRACTOR warrants and represents that it does not use coercion for labor or services as defined in section 787.06, Florida Statutes. CONTRACTOR has executed **Exhibit C**, Nongovernmental Entity Human Trafficking Affidavit, which is attached here to and incorporated herein by reference.

 All other provisions of said Contract, dated December 7, 2021, are hereby confirmed and, except as provided herein, are not otherwise altered or amended and shall remain in full force and effect.
