I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: a Contract with R&D Paving, LLC (R&D), in the amount of \$499,997.56 with a project duration of 250 calendar days for the Green Street Improvements and Related Work Project (Project) at Palm Beach International Airport (PBI).

Summary: The Project provides for improvements to the northbound right turn radius from Military Trail to Green Street and reconstruction of the existing boat ramp along the canal on the western boundary of PBI, including clearing and grubbing, excavation, asphalt milling and paving, new curbing, guardrail removal and replacement, and pavement markings. The Project was advertised on May 12, 2024, utilizing the County's competitive bid process. On June 25, 2024, two (2) bids were received for the Project. R&D, a Palm Beach County company, has been identified as the lowest responsive, responsible bidder in the amount of \$517,962.56; however, R&D requested to reduce the contract amount to \$499,997.56 to lower the required insurance amounts. Since this work is located outside the security fence with no proximity to aircraft, and R&D is a certified Small/Minority/Women Business Enterprise (S/M/WBE) firm, the Department of Airports recommends approval of the Contract at the lower contract amount. The Project was presented to the Goal Setting Committee (Committee) on April 20, 2022, and the Committee established an Affirmative Procurement Initiative (API) of a mandatory 20% SBE subcontracting goal, of which a minimum 5% must be M/WBE. R&D committed to 83.6% SBE and 6.5% M/WBE participation for this Contract. <u>Countywide</u> (AH)

Background and Justification: Military Trail does not have a designated northbound right turn lane onto Green Street, which is a secondary entrance to the west side of PBI. The Project will enhance safety by widening the northbound right turn radius from Military Trail to Green Street to allow a smoother flow of traffic. The Project also provides for the reconstruction of the existing boat ramp along the Airport West Canal to provide access for maintenance of the canal bank.



AECOM Technical Services, Inc. (AECOM) has reviewed the submitted bid proposals for the PB 24-16 project. The established deadline for submission of bids (Bid Due Date) was on June 25, 2024, at 2:00 PM. The Bid Opening was conducted the following day on June 26, 2024, at 2:00 PM by the Palm Beach County Department of Airports at the address shown above.

A total of two (2) bid proposals were received by the Bid Due Date. Bid Proposals were received from R & D Paving, LLC (R&D Paving) and Ranger Construction Industries, Inc. (Ranger). The Bidding documents were presented as two separate Bid Schedules (Schedule I, Green Street Improvements, and Schedule II, Canal Boat Ramp). The Bid Proposal totals which includes Schedule I plus Schedule II, along with the Engineer's Estimate of costs and the bidders Certification of Business Location (Attachment 5 to the Bid Form), are presented in the table below:

AECOM's review indicated that all bid proposals provided complete Primary Bid Documents, Bid Form, Bid Bond (Attachment No. 1) and Unit Price Bid Form (Attachment No. 6), as required for the bid submission. Each bid proposal also included the acknowledgment of all Addenda and provided the Supplemental Bid Documents including the EBO Program Schedules, List of Subcontractors/Self-performed Trades, Trench Safety Affidavit, Certification of Business Location, and the E-Verification Certification. The EBO Program schedules will be reviewed separately by the Palm Beach County Office of Equal Business Opportunity (OEBO). All bidders are located within Palm Beach County while no bidder was identified as a Glades business. AECOM's review found that all bids are complete and should be considered responsive bids.

AECOM's evaluation indicated that all Bidders have experience performing the primary type of services required for this contract and all have their current Florida Contracting licenses. Both R & D Paving and Ranger have performed similar types of services for the County within the past 5 years.



Based on the evaluation of the bids received and review of the qualifications of each bidder, AECOM recommends the PBC DOA award the PB 24-16, Green Street Improvements and Related Work Contract to the lowest responsive bidder, R & D Paving, LLC., contingent on the Palm Beach County Legal and OEBO review of the bid documents.
