The applications submitted to the Department of Justice were for two reentry programs and law enforcement. The ReMarkable 2 tablets and type folios will streamline notetaking efforts by staff attending meetings, including those with law enforcement, reentry, and the community. The tablets can be used for presentations with criminal justice stakeholders. They will also assist in collecting information needed for research evaluations and file reviews, such as determining program recidivism. Staff can use the tablets at trainings and conferences such as the upcoming Reentry Summit. The tablets allow notes to be

converted to text, which increases staff efficiency. Here are the estimates to utilize the remaining grant funds of \$3,132.70.
