

**THIRD AMENDMENT TO THE CONTRACT FOR PROFESSIONAL
CONSULTATION AND EMERGENCY SERVICES IN THE AREAS OF
VETERINARY/MEDICAL SERVICES**

This Third Amendment to the Contract is made as of the 19th day of November, 2024, by and between Palm Beach County, a Political Subdivision of the State of Florida, by and through its Board of Commissioners, hereinafter referred to as the COUNTY, and Veterinary Emergency Group, LLC., a Foreign Limited Liability Company authorized to do business in the State of Florida, hereinafter referred to as the ENTITY, whose Federal I.D. is 82-2020171.

WITNESSETH

WHEREAS, on November 15, 2022, the parties entered into a Contract for Professional Consultation and Emergency Services (R 2022-1383); and

WHEREAS, on August 22, 2023, the parties entered into the First Amendment to the Contract, which provided that ENTITY is entitled to payment for overnight emergency veterinary services in an up to an amount not to exceed \$120,000 (R2023-1135); and

WHEREAS, on November 7, 2023, the parties entered into the Second Amendment to the Contract, which extended the Contract for an additional one-year term (R2023-1653); and

WHEREAS, the parties now wish to extend the Contract for an additional one-year term.

NOW THEREFORE, in consideration of the mutual promises contained herein, the above named parties hereby mutually agree to amend the Contract as follows:

1. The whereas clauses provided above are true and correct and incorporated herein.
2. The Contract is extended for an additional one-year term. The ENTITY shall commence services on 11/15/2024 and complete all services by 11/14/2025. The Parties agree that the ENTITY will be entitled to payment for services rendered beginning on 11/15/2024.
3. Article 34 titled, "DISCLOSURE OF FOREIGN GIFTS AND CONTRACTS WITH FOREIGN COUNTRIES OF CONCERN" is added:

Pursuant to F.S. 286.101, as may be amended, by entering into this Contract or performing any work in furtherance thereof, the Consultant certifies that it has disclosed any current or prior interest of, any contract with, or any grant or gift received from a foreign country of concern where such interest, contract, or grant or gift has a value of \$50,000 or more and such interest existed at any time or such contract or grant or gift was received or in force at any time during the previous five (5) years

4. Article 35 titled, "HUMAN TRAFFICKING AFFIDAVIT" is added:

Consultant warrants and represents that it does not use coercion for labor or services as defined in section 787.06, Florida Statutes. Consultant has executed **Exhibit C**, Nongovernmental Entity Human Trafficking Affidavit, which is attached hereto and incorporated herein by reference.

5. All other provisions of the Contract shall remain in full force and effect.






