I. <u>EXECUTIVE BRIEF</u>

Motion and Title: Staff recommends motion to: (A) accept on behalf of the Palm Beach County Sheriff's Office (PBSO) a Department of Homeland Security, FY 2024 Targeted Violence and Terrorism Prevention Grant Program grant award in the amount of \$700,000 for the retroactive period of October 1, 2024 through September 30, 2026; **(B) approve** a Budget Amendment of \$700,000 in the Sheriff's Grants Fund.

Summary: On September 5, 2024 PBSO received a federal grant award in the amount of \$700,000 to enhance our Palm Beach County School and Community Violence Prevention Project and corresponding comprehensive implementation strategy which addresses threats of mass violence in the community. Funding will be used to support the hire of one (1) full time Detective position, one (1) full time Case Manager position, one (1) full time Intelligence Analyst position, training, supplies, and community awareness. An increase in funding from the County may be requested through our annual budget process once the grant ends to support the three (3) newly added positions. The Office of Attorney General (OAG) Catalog of Federal Domestic Assistance (CFDA) Number for this program is 97.132. The Agreement number is EMW-2024-GR-05163. There is no match requirement associated with this award. Countywide (RS)

Background and Justification: The Department of Homeland Security's mission, founded in the aftermath of 9/11, is to protect the safety and security of the American people. In 2019, the Department added "targeted violence" to its prevention mission, to expand beyond terrorism. Through the Center for Prevention Programs and Partnerships (CP3), DHS coordinates and builds upon a broad range of prevention activities that are currently undertaken across DHS, including grants, community and law enforcement awareness briefings, threat assessments, and information sharing. The Targeted Violence and terrorism Prevention Grant Program provides grants to support state and local organizations to develop capabilities that prevent targeted violence and terrorism.

Hire (1) full time Criminal Intelligence Analyst; (1) full time CIT Case Manager; and (1) full time Detective who will be assigned full time to Palm Beach County Sheriff's Office Behavioral Services Division. Specific responsibilities will include Criminal Intelligence Analyst-criminal intelligence research and analysis using a variety of analytical tools, which can produce intelligence reports on criminal activity, potential threats, and vulnerabilities. CIT Case Manager- developing strategic CIT plan, scheduling CIT classes, scheduling certified trainers, scheduling potential "students", providing support throughout the training process including post-training through certification and feedback loop. A full-time CIT Case Manager staff could fill this void, supporting the CIT training program, as described above, leading to a significant increase in the program's functioning and ultimately in the number of certified personnel both within PBSO and throughout PBC. Detective-working closely with law enforcement to identify persons at risk and in need of services/intervention in Project area; meeting with referred persons and families to assess risk, including behavioral health and related, affecting quality of life needs and likewise providing information, referrals, and linkage to community services and recidivism reduction services as applicable. In addition, participation and support of community outreach, public education, and community engagement to raise societal awareness and better understand violent content and ongoing collaboration with community partners.

Nondiscrimination in Matters Pertaining to Faith-Based Organizations It is DHS policy to ensure the equal treatment of faith-based organizations in social service programs administered or supported by DHS or its component agencies, enabling those organizations to participate in providing important social services to beneficiaries. Recipients must comply with the equal treatment policies and requirements contained in 6 C.F.R. Part 19 and other applicable statues, regulations, and guidance governing the participations of faith- based organizations in individual DHS programs.

Article 27 Non-Supplanting Requirement

Article 30 Procurement of Recovered Materials

States, political subdivisions of states, and their contractors must comply with Section 6002 of the Solid Waste Disposal Act, Pub. L. No. 89-272 (1965) (codified as amended by the Resource Conservation and Recovery Act at 42 U.S.C. § 6962) and 2 C.F.R. § 200.323. The requirements of Section 6002 include procuring only items designated in guidelines of the Environmental Protection Agency (EPA) at 40 C.F.R. Part 247 that contain the highest percentage of recovered materials practicable, consistent with maintaining a satisfactory level of competition.

The Buy America preference only applies to articles, materials, and supplies that are consumed in, incorporated into, or affixed to an infrastructure project. As such, it does not apply to tools, equipment, and supplies, such as temporary scaffolding, brought to the construction site and removed at or before the completion of the infrastructure project. Nor does a Buy America preference apply to equipment and furnishings, such as movable chairs, desks, and portable computer equipment, that are used at or within the finished infrastructure project but are not an integral part of the structure or permanently affixed to the infrastructure project. Waivers When necessary, recipients may apply for, and the agency may grant, a waiver from these requirements. The agency should notify the recipient for information on the process for requesting a waiver from these requirements. (a) When the Federal agency has determined that one of the following exceptions applies, the awarding official may waive the application of the domestic content procurement preference in any case in which the agency determines that: (1) applying the domestic content procurement preference would be inconsistent with the public interest; (2) the types of iron, steel, manufactured products, or construction materials are not produced in the United States in sufficient and reasonably available quantities or of a satisfactory quality; or (3) the inclusion of iron, steel, manufactured products, or construction materials produced in the United States will increase the cost of the overall project by more than 25 percent. A request to waive the application of the domestic content procurement preference must be in writing. The agency will provide instructions on the format, contents, and supporting materials required for any waiver request. Waiver requests are subject to public comment periods of no less than 15 days and must be reviewed by the Made in America Office. There may be instances where an award qualifies, in whole or in part, for an existing waiver described at "Buy America" Preference in FEMA Financial Assistance Programs for Infrastructure | FEMA.gov. Definitions The definitions applicable to this term are set forth at 2 C.F.R. § 184.3, the full text of which is incorporated by reference.

Article 35 SAFECOM

Recipients receiving federal financial assistance awards made under programs that provide emergency communication equipment and its related activities must comply with the SAFECOM Guidance for Emergency Communication Grants, including provisions on technical standards that ensure and enhance interoperable communications. The recipient shall support and facilitate DHS CP3 Grants site visits to assess performance when applicable.
