## I. EXECUTIVE BRIEF

# Motion and Title: Staff recommends motion to:

- A) ratify the signature of the Mayor on the South Florida Water Management District (SFWMD) Indian River Lagoon License Plate Grant application for exotic vegetation removal at Riverbend Park for \$20,000 to cover 50.1% of the project cost, with a County match of \$19,900 or 49.9% from the Parks and Recreation Department's (Parks) operating budget, for the period February 1, 2025 through September 30, 2025;
- **B) authorize** the County Administrator or designee to execute the Grant Agreement (Agreement), as well as task assignments, certifications, standard forms, or amendments to the Agreement that do not substantially change the scope of work or terms and conditions of the Agreement, if the grant is approved; and
- C) authorize the Director of the Parks to serve as Liaison Agent with SFWMD for this project.

**Summary:** This grant application requests \$20,000 from SFWMD to cover 50.1% of the cost of Riverbend Park's exotic vegetation management project. Consistent exotic vegetation management maintains the well-being of the native habitats. Total project costs are estimated at \$39,900, and the County will match the funding request with \$19,900 or 49.9% in operating funds. If awarded, the grant contract will run from February 1, 2025 through September 30, 2025. District 1 (AH)

**Background and Justification**: Riverbend Park is located south of Indiantown Road in northern Palm Beach County and serves as the recreational gateway to the Northwest Fork of the Loxahatchee National Wild and Scenic River. The 665-acre natural area park is vital to the health of the Loxahatchee River. The park attracts over 150,000 visitors annually and contains a variety of subtropical hammocks, lakes, sloughs and prairies, and provides passive recreation at the historic headwaters of the Loxahatchee River. Riverbend Park features 13 miles of shell rock hiking/biking trails, 8 miles of equestrian trails, and 5.3 miles of kayak and canoe trails.

Letter and Application for Riverbend Park

Pursuant to Section 309 of the Administrative Code, your signature is needed on both the required transmittal letter and the 2024 South Florida Water Management District 2024 Indian River Lagoon License Plate grant application. If awarded, this grant will help fund exotic vegetation removal at Riverbend Park. The proposed 200 acres project will benefit the Loxahatchee River primarily by enhancing the overall viability of the ecosystem.

The Parks and Recreation Department is requesting \$20,000, which will be matched with \$19,900 from the Department's operating budget. The one-year grant contract would run from November 2024 until November 2025.

The emergency signature process is being utilized because there is not sufficient time to submit this funding request through the regular Board of County Commissioners' (BCC) agenda process before the application due date of September 30, 2024. Staff will submit the application for the Board's review at the next available BCC meeting.



# EXHIBIT "A" STATEMENT OF WORK

### 1.0 INTRODUCTION

Riverbend Park is a heavily utilized 665-acre passive regional park located in northern Palm Beach County. The park known for its hiking, equestrian and canoe/kayak facilities, is located along the Loxahatchee River and is the southern-most "wild and scenic" river in the continental United States. The headwaters to the Northwest Fork of the Loxahatchee River is the only surviving example of a subtropical cypress forest river system remaining in Florida.

The park features a series of interconnected waterbodies including wetlands and filtering marshes, providing for over five miles of interior canoe and kayak trails. The upland habitats that drain into these waterbodies are in a maintenance program for invasive exotic vegetation. Pest plants that populate these habitats include many different species. If left unchecked these pest plants will spread into the watershed and alter the native habitats that help support the river system.

#### 2.0 BENEFITS TO THE IRL

The elimination of invasive exotics help support native habitats that are all part of the Loxahatchee River ecosystem. Healthier ecosystem results in better water quality.

# 3.0 LOCATION OF PROJECT

The project is located in Riverbend Park, 9060 Indiantown Road, Jupiter, FL 33478. The park is located on the south side of Indiantown Road along the north fork of the Loxahatchee River. The project is located on the Loxahatchee watershed. Please see attached map.

#### 4.0 SCOPE OF WORK

The project includes herbicidal treatment of approximately 200 acres of upland habitat. The contractor will address zones 3, 5, 9, 12, and 14, focusing on target species such as Lygodium, Brazilian pepper, Australian pine, Caesar weed, Acacia, and Java plum. (See map and budget estimate)

### 5.0 WORK BREAKDOWN STRUCTURE

All work will be performed by an annual contractor, who will be responsible for providing all labor, equipment and supplies. Every effort will be made by the contractor to avoid overspray damage to native vegetation. This work will be strictly monitored by Palm Beach County Parks and Recreation Department employees.


