I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to receive and file: the Fiscal Year 2025 (FY 2025) Quarter One (Q1) Small/Minority/Women Business Enterprise (S/M/WBE) participation report.

Summary: The Office of Equal Business Opportunity (OEBO) is tasked with providing a written report on the progress of the program's elements used to increase S/M/WBEs participation in Palm Beach County contracts. The report provides an overview, detailing the outreach activities, certification, Construction Manager at Risk (CM@R) projects, Goal Setting items, waivers, and S/M/WBE payments for FY 2025 Q1. The report serves as a helpful resource for understanding the efforts and progress of each initiative of the Equal Business Opportunity (EBO) Program. The EBO Program is making progress and has positively impacted small businesses in the County; however, continued support of the program remains necessary to achieve parity. <u>Countywide</u> (RS)

Background and Justification: It is the policy of the Board of County Commissioners of Palm Beach County, Florida (BCC), that the County shall use its best efforts to ensure that all segments of its business population, including, but not limited to, small, local, minority, and women-owned businesses, have an equitable opportunity to participate in the County's procurement process, prime contract and subcontract opportunities, and that no business shall be excluded from participation, denied benefits of, or otherwise discriminated against in connection with the award and performance of any contracts with the County on the grounds of race, color, national origin, religion, ancestry, sex, age, marital status, sexual orientation, gender identity or expression, disability or genetic information.





(2) Partnership, which refers to outreach in collaboration with other agencies, organizations, and resource partners. (3) Targeted outreach focuses on specific industries for specific purposes. Notification of these events are distributed through email correspondence and outreach events.




Certification

Certification is the process that OEBO uses to determine whether a firm is a bona-fide small, minority and/or women business enterprise. Firms must satisfy the eligibility criteria for certification every three (3) years to be recertified. The definitions for the SBE certification categories are as follows:

- SBE Small Business Enterprise (Predominately White Males)
- S/WBE Small Women Business Enterprise (Predominately White Females)
- S/MBE Small Minority Business Enterprise (Asian, Black, Hispanic & Other Males)
- S/M/WBE Small Minority Women Business Enterprise (Asian, Black, Hispanic & Other Females)

The following two (2) charts detail the total number of new and recertified vendors by Commission District and certification type, and the overall total of certified vendors by certification type.





It should be noted that M/WBE vendors might be reflected under a different certification type regardless of their race and gender due to individual requests made during the certification period (i.e., a minority/woman vendor requested not to be certified as an S/M/WBE and will be included in the SBE category).


Goal Setting

The Goal Setting Committee (GSC) reviewed 24 proposed projects. Race and/or Gender-Neutral Affirmative Procurement Initiatives (API) were applied to 18 of the aforementioned projects and six (6) of the items presented received Race and/or Gender-Conscious APIs. The MBE and WBE subcontracting goals ranged from three (3) percent to 20 percent participation based on the availability of certified M/WBEs.

Three (3) Post-Bid waivers, One (1) Good Faith Effort waiver, and Two (2) Departmental waivers were granted during this reporting period.



Small/Minority/Women Business Enterprise Participation

The following charts on pages six (6) through eight (8) reflect S/M/WBE participation during this reporting period. The data presented displays the overall sum of payments made to both prime contractors and subcontractors across all industries to provide a comprehensive view of small business involvement in the County's procurement activity. The data also include funds disbursed to small businesses related to ongoing contracts from the previous Small Business Enterprise (SBE) program, and exempt purchases and contracts awarded through the current Equal Business Opportunity (EBO) program that have been recorded since FY2019. Payments made to minority businesses include males and females. The definitions for the SBE categories are as follows:

- SBE Small Business Enterprise (Predominately White Males)
- S/WBE Small Women Business Enterprise (Predominately White Females)
- S/MBE Small Minority Business Enterprise (Asian, Black, Hispanic, & Other Males)
- S/M/WBE Small Minority Women Business Enterprise (Asian, Black, Hispanic, & Other Females)

Non-Exempt SBE Contract Payments

This SBE summary report includes payments made from non-exempt agreements of the previous SBE program. The contracts under the SBE Program will continue to run until the contracts are complete. There are 60 active contracts as of the run date.


